FP7 Key facts and figures

Applications:

As of 2013/10/25, a total of

- 794 eligible proposals were submitted in response to 467 FP7 calls for proposals
- involving 849 applicants from SACHSEN-ANHALT (1,22% of DE and 0,17% of EU-28*)
- requesting EUR 237,77m of EC contribution (0,83% of DE and 0,13% of EU-28*)

Among the NUTS1 regions of Germany (DE), SACHSEN-ANHALT ranks:

- 14th in terms of number of applicants and
- 15th in terms of requested EC contribution

Among the NUTS1 regions of EU-28*, SACHSEN-ANHALT ranks:

- 83rd in terms of number of applicants and
- 82nd in terms of requested EC contribution

Success rates:

- The SACHSEN-ANHALT applicant success rate of 19,3% is lower than the DE applicant success rate of 24,3% and lower than the EU-28* applicant success rate of 20,9%.
- The SACHSEN-ANHALT EC financial contribution success rate of 17,2% is lower than the DE rate of 23,7% and lower than the EU-28* rate of 19,7%.

Specifically, following evaluation and selection, a total of

- 158 proposals were retained for funding (19,9%)
- involving 164 (19,3%) successful applicants from SACHSEN-ANHALT and
- requesting EUR 40,83m (17,2%) of EC financial contribution

Among the NUTS1 regions of Germany (DE), SACHSEN-ANHALT ranks:

- 16th in terms of applicants success rate and
- 16th in terms of EC financial contribution success rate

Among the NUTS1 regions of EU-28*, SACHSEN-ANHALT ranks:

- 66th in terms of applicants success rate and
- 60th in terms of EC financial contribution success rate

Signed grant agreements

As of 2013/10/25, SACHSEN-ANHALT participates in

- 157 signed grant agreements
- involving 2.339 participants of which 164 (7,01%) are from SACHSEN-ANHALT
- benefiting from a total of EUR 622,66m of EC financial contribution of which EUR 42,69 m (6,86 %) is dedicated to participants from SACHSEN-ANHALT.

Among the NUTS1 regions of Germany (DE), SACHSEN-ANHALT ranks:

- 15th in number of participations and
- 16th in budget share

Among the NUTS1 regions of EU-28*, SACHSEN-ANHALT (DE) ranks:

- 85th in number of participations and
- 82nd in budget share

SME performance and participation

- The SACHSEN-ANHALT SME applicant success rate of 18,08% is lower than the DE SME applicant success rate of 22,92% and it is lower than the EU-28* SME applicant success rate of 20,17%.
- The SACHSEN-ANHALT SME EC financial contribution success rate of 16,33% is lower than the corresponding DE rate of 23,21% and it is lower than the corresponding EU-28* rate of 20,08%.

Specifically,

- 260 SACHSEN-ANHALT SME applicants requesting EUR 68,19m
- 47 (18,08%) successful SMEs requesting EUR 11,13m (16,33%)

In signed grant agreements, as of 2013/10/25,

- 43 SACHSEN-ANHALT SME grant holders, i.e., 26,22% of total SACHSEN-ANHALT participation
- EUR 8,55m, i.e., 20,03% of total SACHSEN-ANHALT budget share

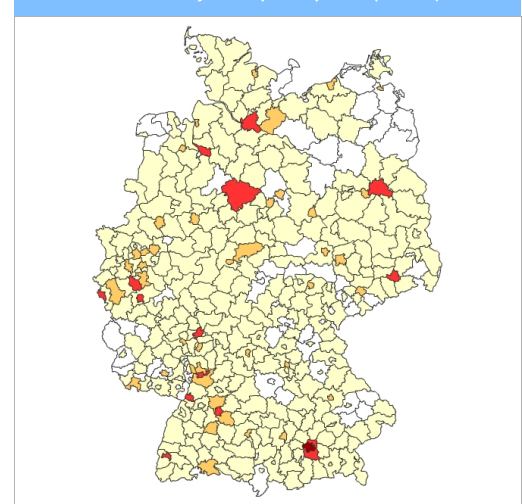
