



FP7 Key facts and figures

Applications:

- As of 2013/10/25, a total of 2.654 eligible proposals were submitted in response to 467 FP7 calls for proposals involving 3.040 applicants from SACHSEN (4,35% of DE and 0,60% of EU-28*) requesting EUR 947,25m of EC contribution (3,31% of DE and 0,52% of EU-28*)

Among the NUTS1 regions of Germany (DE), SACHSEN ranks:
 - 7th in terms of number of applicants and
 - 7th in terms of requested EC contribution

Among the NUTS1 regions of EU-28*, SACHSEN ranks:
 - 50th in terms of number of applicants and
 - 45th in terms of requested EC contribution

Success rates:

- The SACHSEN applicant success rate of 24,1% is similar to the DE applicant success rate of 24,3% and higher than the EU-28* applicant success rate of 20,9%.
- The SACHSEN EC financial contribution success rate of 25,0% is higher than the DE rate of 23,7% and higher than the EU-28* rate of 19,7%.

Specifically, following evaluation and selection, a total of 642 proposals were retained for funding (24,2%) involving 733 (24,1%) successful applicants from SACHSEN and requesting EUR 236,37m (25,0%) of EC financial contribution

Among the NUTS1 regions of Germany (DE), SACHSEN ranks:
 - 7th in terms of applicants success rate and
 - 7th in terms of EC financial contribution success rate

Among the NUTS1 regions of EU-28*, SACHSEN ranks:
 - 24th in terms of applicants success rate and
 - 21st in terms of EC financial contribution success rate

Signed grant agreements

- As of 2013/10/25, SACHSEN participates in 619 signed grant agreements involving 8.601 participants of which 714 (8,30%) are from SACHSEN benefiting from a total of EUR 2.882,80m of EC financial contribution of which EUR 245,14 m (8,50 %) is dedicated to participants from SACHSEN.

Among the NUTS1 regions of Germany (DE), SACHSEN ranks:
 - 7th in number of participations and
 - 7th in budget share

Among the NUTS1 regions of EU-28*, SACHSEN (DE) ranks:
 - 44th in number of participations and
 - 39th in budget share

SME performance and participation

- The SACHSEN SME applicant success rate of 23,37% is similar to the DE SME applicant success rate of 22,92% and it is higher than the EU-28* SME applicant success rate of 20,17%.
- The SACHSEN SME EC financial contribution success rate of 25,01% is higher than the corresponding DE rate of 23,21% and it is higher than the corresponding EU-28* rate of 20,08%.

Specifically,
 - 796 SACHSEN SME applicants requesting EUR 225,72m
 - 186 (23,37%) successful SMEs requesting EUR 56,44m (25,01%)

In signed grant agreements, as of 2013/10/25,
 - 160 SACHSEN SME grant holders, i.e., 22,41% of total SACHSEN participation
 - EUR 45,72m, i.e., 18,65% of total SACHSEN budget share

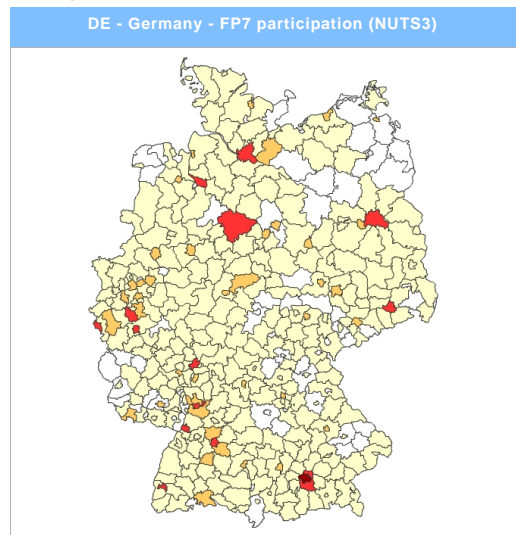
