



FP7 Key facts and figures

Applications:

- As of 2013/10/25, a total of 1.117 eligible proposals were submitted in response to 467 FP7 calls for proposals
- involving 1.246 applicants from THÜRINGEN (1,78% of DE and 0,25% of EU-28*)
- requesting EUR 394,76m of EC contribution (1,38% of DE and 0,21% of EU-28*)

Among the NUTS1 regions of Germany (DE), THÜRINGEN ranks:

- 12th in terms of number of applicants and
- 12th in terms of requested EC contribution

Among the NUTS1 regions of EU-28*, THÜRINGEN ranks:

- 77th in terms of number of applicants and
- 73rd in terms of requested EC contribution

Success rates:

- The THÜRINGEN applicant success rate of 20,2% is lower than the DE applicant success rate of 24,3% and similar to the EU-28* applicant success rate of 20,9%.
- The THÜRINGEN EC financial contribution success rate of 19,2% is lower than the DE rate of 23,7% and similar to the EU-28* rate of 19,7%.

Specifically, following evaluation and selection, a total of

- 233 proposals were retained for funding (20,9%)
- involving 252 (20,2%) successful applicants from THÜRINGEN and
- requesting EUR 75,64m (19,2%) of EC financial contribution

Among the NUTS1 regions of Germany (DE), THÜRINGEN ranks:

- 15th in terms of applicants success rate and
- 14th in terms of EC financial contribution success rate

Among the NUTS1 regions of EU-28*, THÜRINGEN ranks:

- 62nd in terms of applicants success rate and
- 50th in terms of EC financial contribution success rate

Signed grant agreements

As of 2013/10/25, THÜRINGEN participates in

- 237 signed grant agreements
- involving 2.694 participants of which 257 (9,54%) are from THÜRINGEN
- benefiting from a total of EUR 888,62m of EC financial contribution of which EUR 85,67 m (9,64 %) is dedicated to participants from THÜRINGEN.

Among the NUTS1 regions of Germany (DE), THÜRINGEN ranks:

- 12th in number of participations and
- 12th in budget share

Among the NUTS1 regions of EU-28*, THÜRINGEN (DE) ranks:

- 75th in number of participations and
- 62nd in budget share

SME performance and participation

- The THÜRINGEN SME applicant success rate of 20,23% is lower than the DE SME applicant success rate of 22,92% and it is similar to the EU-28* SME applicant success rate of 20,17%.
- The THÜRINGEN SME EC financial contribution success rate of 19,03% is lower than the corresponding DE rate of 23,21% and it is lower than the corresponding EU-28* rate of 20,08%.

Specifically,

- 440 THÜRINGEN SME applicants requesting EUR 126,28m
- 89 (20,23%) successful SMEs requesting EUR 24,03m (19,03%)

In signed grant agreements, as of 2013/10/25,

- 85 THÜRINGEN SME grant holders, i.e., 33,07% of total THÜRINGEN participation
- EUR 24,51m, i.e., 28,62% of total THÜRINGEN budget share

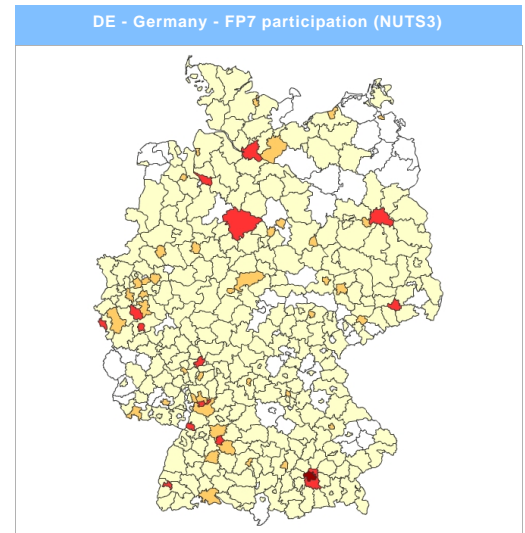
